CLASS DESCRIPTION

Class description: The U.S. is the highest per capita spender on healthcare among developed nations. It has a unique and uniquely complicated healthcare structure distinct from other countries. Is it a good or bad thing for the US population? This course examines both the theories and empirics of multiple topics in Health Economics. Students will learn that Health Economics is fundamentally different than regular economics in every aspect covered in the course: Demand, Supply, Adverse Selection, Moral Hazard, Insurance, Policy, and so on. Each topic will contain a balanced structure between theory and accompanying empirical studies.

Course Objective: At the end of this course, students should demonstrate their ability to apply economic models and their understanding of research methods to analyze different topics within Health Economics.

BASIC COURSE FLOW

Students are expected to do the readings beforehand for assigned chapters and engage in discussion in class. Biweekly, there will be an assignment covering the topics discussed during the weeks. The assignment is due at the dates specified on the schedule.

There are 2 exams and 1 paper on specified dates. Before each exam, there will be review sessions to cover important topics. This includes going through the answers to the homework relevant to the exams.

ASSESSMENT

Components

- Assignments: 6 Homework, lowest dropped, 2% each. Total = 10%
 Homework is due on the specified date on the syllabus, in the form of either multiple choice or short answer/essay/calculations, due at the end of the following week. There are a total of 6 homework assigned to students, 5 of which count towards the final grade.
- Exams: 2 Exams, 15% each. Total = 30%

 Two exams are equally weighed (15% each) towards the final grade. Exams are divided into Multiple choice and essay/calculation questions. Topics are based on the concepts introduced in class and homework from relevant topics.
- **Project:** 50% Essay + 10% presentation = 60% Students can work individually or in a group of three. Choose yourself a country or state of interest to write a comprehensive urban economic report about. More details to be posted later on Brightspace.
